# **Privacy Policy**

## 1. Information Collection and Utilization

Decorative Concrete of South Louisiana, LLC ("us", "we", or "our") is the operator of the website <a href="www.decorativeconcrete-southla.com">www.decorativeconcrete-southla.com</a> (the "Site"). This document serves to inform you of our policies regarding the collection, use, and disclosure of Personal Information obtained from users of the Site. We utilize your Personal Information to enhance the Site, communicate with you regarding services you have requested, deliver those services, process payments, and follow up on services we have provided. By accessing and using the Site, you consent to the collection and use of information in accordance with this policy.

We collect the following types of Personal Information from users:

- Contact Information: This includes your name, phone number, address, and email.
- Log Data: This includes information that your browser sends, such as your computer's Internet Protocol ("IP") address, browser type, pages of our Site that you visit, the date and time of your visit, and the duration spent on those pages.
- **Consent Records:** We may collect and store records of your consent to receive communications from us.

We are committed to safeguarding your privacy and **do not sell, trade, or otherwise transfer your personal information to third parties or affiliates for marketing purposes** without your explicit consent, unless compelled by a valid court order. Your information may be shared with or accessible by our partnered service providers, who assist us in delivering our services. For payment processing, we use Stripe, which securely handles all financial information directly. We do not store or have access to your credit card details or other sensitive payment information on our servers. Other providers include Odoo for software and cloud services, and Google Workspace for cloud and software services.

#### 2. Service-Related Data

In the course of providing our services, we may collect and maintain records related to a project, including but not limited to, job notes, project specifications, and photographs or videos of the work before, during, and after completion. We collect this data for internal purposes, such as quality control, project documentation, and to maintain a portfolio of our work. We will only use photos or videos of your project for our public-facing portfolio or other promotional purposes after obtaining your separate, explicit written consent.

#### 3. Communications

- Email: We may use your Personal Information to contact you with service-related updates and other important announcements. You can unsubscribe by emailing us at info@decorativeconcrete-southla.com.
- **SMS:** If you opt in, we will use your phone number to communicate about your inquiries and to provide service-related updates. Message frequency varies. We will share your phone number and opt-in status with our third-party service providers solely for the purpose of delivering these messages. We will also retain information as needed to comply with our legal obligations, resolve disputes, and enforce our policies.
